## **NOTES:**

1. The Ministry of Corporate Affairs (MCA) has permitted companies to conduct Annual General Meeting (AGM) through video conferencing (VC) or other audio-visual means, subject to compliance of various conditions mentioned therein. In compliance with the MCA Circulars and applicable provisions of Companies Act, 2013, the 8<sup>th</sup>AGM of the Company is being convened and conducted through VC without the physical presence of Members at a common venue.

2. Since the Company is not required to conduct e-voting, the voting at the meeting shall be conducted through show of hands, unless demand for a poll is made by member in accordance with Section 109 of the Companies Act, 2013. In case a poll is demanded, then the members shall cast their vote through an email and their vote shall be sent to secretarial@connectindia.com.

4. As per the provisions under the MCA Circulars, Members attending the 8th AGM through VC shall be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.

5. Corporate Members intending to send their authorized representatives to attend the AGM are required to send a duly certified scanned copy of their Resolution authorizing them to attend and vote through VC/OAVM on their behalf at the AGM by e-mail to secretarial@connectindia.com.

6. As per the Companies Act, 2013, a Member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his/her behalf. Since the 8th AGM is being held through VC as per the MCA Circulars, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be made available for the 8th AGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice.

7. In line with the MCA Circulars, the notice of the 8th AGM along with the Annual Report 2021-22 are being sent only by electronic mode to those Members whose e-mail addresses are registered with the Company.
